

Aims and Mission

To deliver 15 / 30 hour government funded hours, sharing a clear, precise, fair, up to date, accessible price list. This will enable parents to make an informed choice about their provider.

We are mindful of the impact of additional charges on families, particularly the most disadvantaged.

We provide parents a variety of optional ways to use their full entitlement and do no charge top up fees for funded hours.

Our invoices are itemised allowing parents to clearly see what they are being charged for.

Fees and funding policy

At 2 Little Birds and Hutton Preschool 2LB (herein “the company”) we pride ourselves on being competitively priced, offering parents the opportunity to use their funding in the most cost-effective way for them. We try to keep any additional charges to a minimum.

The company endeavour to have clear and straightforward pricing, with no hidden costs. Further details can be found in the parental partnership, however for clarity parents must give one full terms notice to terminate and must adhere to the local authority funding agreement.

Parents who wish to access their full entitlement without any additional charges at all will only be able to access their hours as follows:

15 hrs: 9:00-12:00 or 12.30-15:30 Monday to Friday

30 hrs: 7:00-13:00 or 12:00-18:00 Monday to Friday.

We are keen to support working parents in the most cost-effective way possible, and the following will be applied to any variations to the funded hours.

- Any child who is paying for their sessions will be charged as below.
- Children who are stretching their offer across 50 weeks of the year will be entitled to 22 hours per week funded and these will be assigned as Monday and Tuesday as standard.
- All children attending Preschool sessions will be charged a consumable charge of £1 per session (£2 for a full day), commencing from October 2025. The consumable charge on the invoice includes not only food for snack but other items such as wipes, nappies etc, in addition to this other enhancement activities, such a visits, trips, baking, other specialist activities.
- If a child is going to be out of preschool for a holiday, provided we are given notice prior to the invoice being issued, and with at least 6 weeks' notice, we will adjust the invoice accordingly.
- No credit is given for missed sessions when a child is absent without notice or for sickness.
